KNOWINGLY AND FREELY ASSUME ALL SUCH RISKS, both known and unknown, EVEN IF ARISING FROM THE NEGLIGENCE OF THE RELEASEES or others, and assume all full responsibility for my participation; and, 3. Willingly agrees to comply with the stated and customary terms and conditions for participation. If however he/she observes any unusual significant hazard during his/her presence or participation, he/she will remove him/herself from participation and bring such to the attention of the nearest official immediately; and, 4. Acknowledges, appreciates, and agrees that he/she has read this form and understand that by signing this form, he/she is giving up legal rights and remedies on behalf of him/herself and his/her family, estate, heirs, and/or assigns; and 5. TEAM NAME \_\_\_\_\_

Format of event: U5-U12 will play 3V3 / Games with two 12-minute halves separated by a two-minute halftime. Box rule 3v3 – Players cannot stand inside the box. Players may pass through the box: however, there cannot be any contact with the ball inside the box. The offensive team will be awarded a goal if the defending team touches the ball in the box. If an offensive team touches the ball within the box, a goal kick is awarded to the defensive team. If the ball comes to a stop inside the box, a goal kick is awarded to the defensive team.

U13 – Adults will play 6v6 / Games will consist of two 20-minute halves separated by a two-minute halftime.

No Offsides in 3v3 or 6v6 soccer. No Slide Tackling that makes contact with an opposing player; however, you may slide to save a ball from going out of bounds. Scoring a goal may be scored only from a touch within a team's offensive half of the field. The ball must be completely on the offensive half of the field and cannot be

touching the mid-line. No build out line in either formats. WINNING COACH will bring scorecard to Tournament Headquarters following the game!
